1. Kaci Rollings called the meeting to order at 8:30 a.m.

2. Doris Groves shared historical information regarding the RED committee and the current challenge of clarifying the continuing purpose of the committee. When there were very specifically defined requirements for the chapters and clubs that comprised the Alumni Association, then there were more specific duties for the RED committee. Today most geographic networks and most affinity groups are more loosely structured because there are typically only 1-3 primary volunteers in each area (geographic networks) or they are affiliated with an academic college or department (MCN, Agriculture). As a result, there are fewer responsibilities for RED to manage. There are still opportunities for RED to engage with networks and affinity groups (i.e. appreciation notes, etc.) but these duties may not be enough to keep an entire committee productive.

As a result of this challenge, in the summer of 2016, Doris, Colleen Rice, Lindsay Vahl and President Tim Pantaleone met regarding RED. One observation noted at this meeting was that most successful AA committees have a specific event, task or responsibility that needs to be accomplished (i.e. Scholarship Committee completes scholarship selection process; Awards Committee completes Award selection process and Awards recognition dinner). One possibility for RED that was identified by this group was Civic Engagement which is a core value of the University. As a result of this conversation, the RED committee was encouraged to explore this opportunity and to try to complete a service project for the board during 2016-17. This service project was accomplished in April 2017.

However, it seemed clear that there was still some confusion about the definition of Civic Engagement and the ways that it might be meaningful for the Alumni Association to promote it. For example, it might include encouraging networks/affinity groups to have a day or month of service as some alumni may be interested in gathering for this purpose, rather than a social activity. It could involve advocacy work on the state level. It might include sharing opportunities for alumni to participate in campus activities related to civic engagement.

In order to have a better understanding of what civic engagement entails and to share some

In order to have a better understanding of what civic engagement entails and to share some opportunities for AA involvement, Dr. Jan Paterson was invited to the meeting to share more information.

3. Civic Engagement Presentation: Dr. Jan Paterson, Interim Director for Civic Engagement, shared information about what comprises civic engagement. The general definition accepted by ISU is Illinois State University prepares students to be informed and engaged global citizens who will promote and further the goals of society. The University promotes active learning experiences through which students will gain an awareness and understanding of civic engagement as a lifelong responsibility. Dr. Paterson shared information about the reasons ISU is embracing civic engagement and the stages of engagement. She also shared a variety of opportunities locally that could be considered.

- 4. Committee members asked a variety of questions. Ryan Gilbert expressed an interest in the possibility of having alumni in areas around the country meet students who are participating in Alternative Breaks in their locations. Fellicia Foster indicated that her employer supports a day of service that encourages employees to be involved in their communities.
- 5. Based upon the conversation, it appears that there is interest in learning more about civic engagement and investigating what this might look like for the RED committee. Mike Willis indicated that he would like to see a project completed again this year. There was interest in asking Dr. Paterson to attend a future meeting of the Alumni Board so that all members can increase their understanding of this topic.
