Board Development Committee Illinois State University January 21, 2017 Update

1) Board Resource webpage review--

Rachel Kobus provided a template of the board resources page which will be added to the Alumni Association Board of Directors tab on the Alumni website. It will include the board manual, as well as agendas, meeting minutes and committee reports for individual meetings. The committee approved of the format. Rachel will move forward with making it live by the April board meeting.

2) Board involvement survey form

The Board Development committee was given the opportunity to review the Board Involvement Form which can be used to gather collective information about the activities and impact of our board members. This information will be shared with the entire board at the January 21 meeting. This form will be sent out quarterly, but it will also always be accessible via the Board Resource Page.

3) Board member and leadership planning for 2017-18

Kaci Rollings advised that the annual meeting of the ISU Alumni Association is scheduled for June 24, 2017. She has been in contact with each of the individuals whose terms will be expiring in June. One board member, Bob Freitag, will have completed his 12 year term in June and will not be eligible for renewal. It's possible that one or two additional individuals may choose not to renew. On January 20 it was announced that Julie Jones will be joining the ISU Board of Trustees, so her position may also become available. Kaci expects that we will have 3-4 positions to fill in June 2017.

Doris Groves provided the committee with a listing of current applicants for the board positions. During the month of February, she will review the list and reach out to each qualified candidate to discuss the position and the expectations. She will then forward the information on the candidates, along with demographic information and a ranking spreadsheet to the committee members. Once each committee member has had an opportunity to rank, a meeting will be scheduled to identify the candidates recommended for the slate. This meeting will take place in late March. In addition to identifying new members, the committee will also need to identify members to fill leadership and Executive Committee spaces. The Board Development committee will plan to meet in advance of the next board meeting on April 8.

Kaci reported that one of the next tasks of the Board Development committee will be to plan for new member orientation and to implement a mentorship program for new board members.

Illinois State University Alumni Association Scholarship Committee Update 4/8/17

The Scholarship committee has completed its selection process for the 2017-18 academic year. Of 174 applicants, the Financial Aid Office forwarded the fifteen most qualified candidates to the committee to review. After the initial review, the candidates were interviewed by telephone on March 21. Based on this review five Alumni Association Scholarships were awarded. For 2017-18 this group will join five returning scholarship recipients for a total of ten scholarship students on campus. These scholarships are valued at \$2,000 annually.

In addition to the Alumni Association scholarship recipients, 17 legacy tuition waivers, one Dillow Legacy scholarship and three Marian H. Dean Scholarships were awarded from the pool of candidates. These legacy awards are valued at \$1,000 annually and are not automatically renewable.

Each new recipient has until May 1 to accept the scholarship offer. Once this date has passed, the committee will provide brief bios for each recipient.
