Call to Order

Reeves (President) called the meeting to order at 9:41 a.m. at the Illinois State University Alumni Center. He welcomed the board members and noted there would be an annual meeting of the alumni association membership immediately follow the conclusion of the board meeting.

University Update

Jan Murphy, Vice President for Academic Affairs and Provost, provided an update on behalf of President Larry Dietz who was on vacation. The following information was shared with the board:

- The 101st General Assembly adopted a budget for upcoming fiscal year of \$69.6 million a 5% increase over previous year's appropriation
- Funds were increased for monetary awards program (MAP) along with added funds for the new Aim High program
- Funds were also approved for several new and renewed capital projects (approved but not released)
 including renovation the Fine Arts complex and Milner Library
- No tuition increase was approved by the Board of Trustees although a modest academic fee increase was approved
- Fall 2019 will welcome the largest incoming freshman class in recent years; enrollment closed for first time since 2014
- Incoming freshman and transfer students are more diverse than ever before
- There has been significant growth in Honor Program
- ISU educates the third largest number of students in Illinois
- Forbes recognized Illinois State as one of the best mid-sized employers in the United States
- Kathy Bohn and Bob Navarro were appointed to Board of Trustees
- Redbird Athletics won Missouri Valley Conference All-Sports Championship recognition

University Advancement Update

Mark Wunder, Assistant Vice President for Development, provided an update on behalf of Pat Vickerman, Vice President for University Advancement. The following highlights were shared with the board:

- The Redbird Rising Campaign surpassed its goal reaching more than \$155 million as of June 2019
- Over 51,000 donors, including 23,000 first-time donors, have supported the campaign
- 25 visionary gifts and commitments of \$1 million or more have also been received
- Annual giving has totaled \$39 million
- Campaign funds will support scholarship, leadership and innovation initiatives
- The Birds Give Back One Day for Change event help on Feb. 28 raised \$625,494 from \$1,734 gifts
- Campus support for the campaign remains strong from faculty and students
- New Redbird socks are now available for purchase

Trustee's Remarks

Julie Jones, Board of Trustee liaison, shared updates from the May Trustees meeting related to confirmation of new and returning Board of Trustees and decisions not to increase tuition but instead, adjusted academic fees. She also shared information about newly funded projects, including HVAC upgrades at Watterson Towers, Bone Student Center concourse improvements, Julian Hall enclosure project and the purchase of property on Locust Street for future use.

Enrollment Management Update

Jeff Mavros, Director of Admissions, gave an in-depth presentation on Illinois State University recruitment and retention initiatives, emerging trends, and opportunities for alumni engagement and outreach with prospective students and their families.

President's Report

Reeve shared that he has been honored to participate in numerous activities with the University during the second quarter of 2019, including:

- Alumni Association Board Meeting and the Special Membership Meeting
- Planning and participation associated with the Phoenix alumni event
- Board Development Committee calls related to selection and interviews of prospective Board and Executive Committee candidates
- Coordination and engagement in a staff appreciation luncheon and recognition awards for the Ag Department
- Assembly of keychains for spring commencement
- The Glass House alumni event
- Half Century Club events including the welcome lunch, reception and induction ceremony for the class of 1969

Executive Director's Report

Harding provided updates on the several items, including:

- Alumni Engagement welcomed Danielle Brady and Lea Atas as graduate assistants, as well as Abby Wolski and Laura Ledin, who are serving as summer interns
- Half Century Club reunion, held on April 26 & 27, hosted more than 70 guests for Friday lunch and 90 at the induction dinner
- Approximately 95 guests attended the Alumni Association/College of Fine Arts reception in New York City
- Over 230 Redbirds attended the White Sox pregame event
- Successful network events have been held in recent months in Peoria, Dallas, Washington DC, Atlanta, and St. Louis
- The Mennonite College of Nursing Gala was well attended and successful
- #RedbirdImpact events are happening across the country including locally with Alumni Association Board member participation
- Upcoming events include:
 - ISU Night at Chicago Cubs on June 25 and Peoria Chiefs on June 29
 - The Student Affairs Legacy of Leadership event on July 22
